FEMA Hazard Mitigation Grant Project

I am happy to report that all work related to this grant has been completed. All 7 reimbursement requests have been paid totaling \$5,619,465.81. This project was a team effort and consumed many hours of time from numerous departments such as Engineering, Zoning, Building, Purchasing and Finance. It could not have been completed if it were not for very dedicated employees who worked tirelessly on the project and the other individuals that made sure the normal operations of these departments continued. I am very proud of everyone's commitment and those who put their heart and soul into this long and challenging project to help those most affected by the storm. (No Council Action Required)

Major Soil Moving Permit-Caggiano Properties, LLC, Block 393 Lot 1

The Planning Board has recommended approval of a major soil moving permit in conjunction with the site plan application at 272 Parsippany Road. This office has reviewed the application and recommends the Township Council approve the permit. (We recommend the Township Council approve the permit by resolution).

Church of the Living Grace, Performance Guarantee Release - Block 740 Lot 4

The developer completed all site work in accordance with the approved plans. Inspections were made during the course of construction and this office has no objection to the release of the performance guarantee in the form of a Letter of Credit (#20008006). (A Resolution will need to be adopted by the Township Council).

Mike Fitzpatrick & Son, Inc. Performance Guarantee Release – Block 737 Lot 2

The developer completed all site work in accordance with the approved plans. Inspections were made during the course of construction and this office has no objection to the release of the performance bond (#B1174185). (A Resolution will need to be adopted by the Township Council).

Knoll Road Improvement Project

The bid opening for the Knoll Road Improvement project will be held on May 3rd. This project is for the improvements to Knoll Road from Vail Road to Buckingham Road and includes drainage improvements, curb installation and roadway reconstruction. We anticipated construction to begin in June. (If acceptable bids are received we will make our recommendation that the Township Council award the project at the May 15th meeting).

Mt. Tabor Area Streets, Phase III Improvement Project

The bid opening for the third phase of the Mt. Tabor Area Streets will be held on May 1st. This project is for the reconstruction of <u>Strowbridge Avenue</u> – between West Morris Avenue and St. John's Avenue, <u>Sommerfield Avenue</u> – between Strowbridge Avenue and W. Park Place, <u>Hedding Place</u> – between Strowbridge Avenue and Wesley Place, <u>Wesley Place</u> – between

Sommerfield Avenue and W. Morris Avenue, <u>Morris Avenue</u> – between Wesley Place and Boehm Avenue, <u>Fletcher Place</u> – between Morris Avenue and Dickerson Road, <u>Whitfield Place</u> - between Morris Avenue and Dickerson Road, <u>Boehm Avenue</u> - between Morris Avenue and Dickerson Road, and <u>Simpson Avenue</u> – between Wesley Place and Boehm Avenue. The project includes significant drainage improvements, curb construction and the reconstruction of the roadways. We anticipated construction to begin sometime in June. (If acceptable bids are received we will make our recommendation that the Township Council award the project at the May 15th meeting).
