2020-2021 Budget Directive

To direct the administration to adhere to the following goals in the construction of the 2020-21 school operating budget:

- Manage and control expenses in the operating budget with the goal of achieving an end of the year surplus of 2.5% of the total operating budget
- Provide adequate funding that does not diminish, to the greatest degree possible, current services to students, including facilities and security and support the goals of the Strategic Plan.
- Ensure a tax levy of 2% exclusive of the SGLA (spending growth adjustments) and banked cap.

The 2020-2021 Budget provides for:

- ❖ Science instructional materials, including new kits for the elementary Life Science units, updated middle school textbooks/online resources, and high school Biology textbooks/online resources.
- ❖ New materials for high school Robotics classes.
- ❖ Additional novels at the middle and high schools.
- ❖ Professional development to support new STEM opportunities and a 3-year sequence of courses leading to CCNA certification.
- ❖ Additional staff to support the growing elementary Strings program, Mandarin Chinese, additional Special Education enrollments, and a school-based therapeutic program (Tier I and II).
- ❖ Renewal of *Go Math* textbook and online program for K-5.
- ❖ Continued security through our partnership with the Township for School Resource Officers and Class III Officers.

Additional State Aid for 2020-2021

We received additional State Aid for 2020-2021 in the amount of \$914,932 which will be applied toward:

1. Negotiated salaries and benefits increased 3.64% as a result of concluded negotiations, additional staff hired for 2019-20 and new hires for 2020-21 **\$3,279,047**
2. Student enrollment at Morris County Vocational Technical School has increased over the last three years **\$625,523**
3. Increased transportation costs **\$335,000**
4. Technology enhancements **\$99,864**

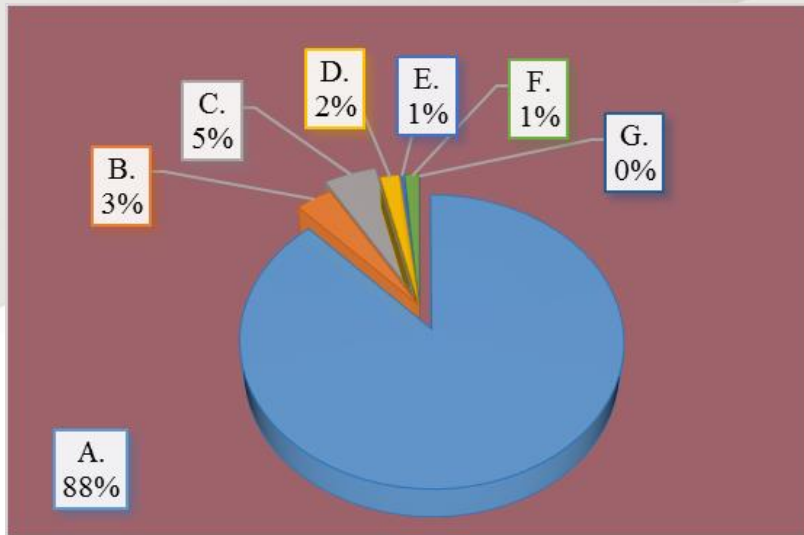

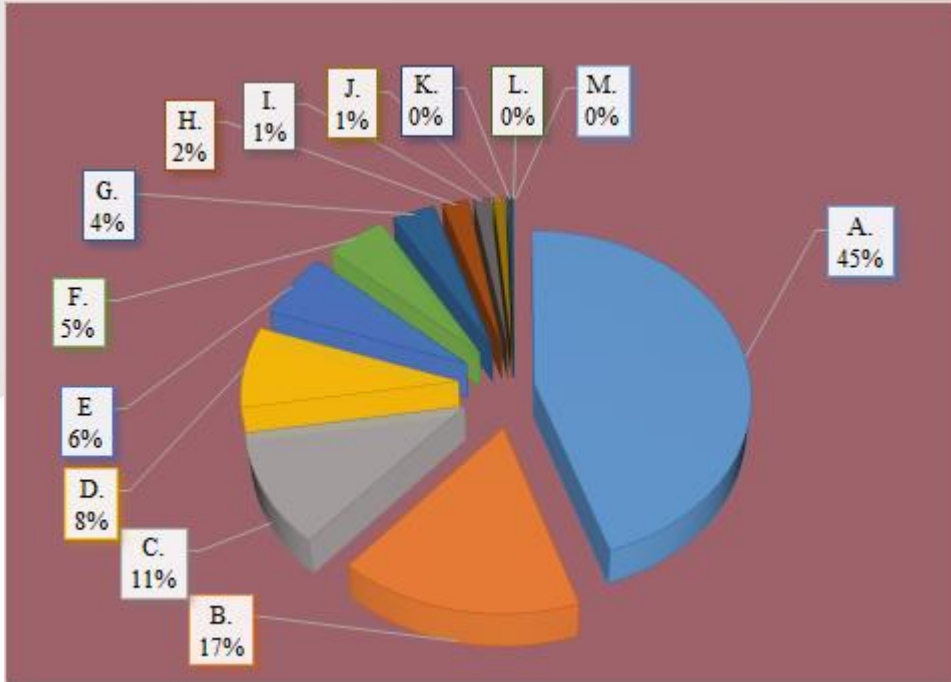
Revenue Sources
