Greenbank Road Safety and Improvements Project

The adjustments to the streambed have been made and the new guiderail will be installed by the end of September. Project closeout will be completed by the end of October. (No Council Action Required).

2021 Road Resurfacing / Curb and Sidewalk Program

The annual road resurfacing / curb and sidewalk project is on hold pending negotiations with the contractor. **(No Council Action Required).**

Puddingstone Heights Road Improvement Project, Phase I

Construction on the Puddingstone Heights Improvement project is substantially complete. We anticipate all remaining punch list items to be completed in the next several weeks. (No Council Action Required).

Rockaway River Floodwall / Levee Inspection

Our consultant is working on preparing design details and a cost estimate for the maintenance and repair work to the flood wall and levee. All vegetation within 5 feet of the wall and toe of slope is being cleared in accordance with our inspection requirements. **(No Council Action Required).**

<u>Traffic Signal Maintenance for Littleton Rd. & Rita Dr./Beachwood Rd. and the Jefferson Rd. &</u> <u>Smith Rd. Intersections</u>

This project is for improvements and maintenance to the traffic signals located at the Littleton Road & Rita Drive/Beachwood Road intersection and the Jefferson Road & Smith Road intersection. The improvements include the replacement of various signal detection and controller equipment that have failed. Work will begin once equipment is available. **(No Council Action Required).**

2022 Road Resurfacing / Curb and Sidewalk Program

The 2022 road resurfacing / curb and sidewalk project is approximately 75% complete. All work is anticipated to be complete by the end of September. **(No Council Action Required).**

North Beverwyck Road Streetscape Project, Phase I

The first phase of the North Beverwyck Road Streetscape project is in design. We anticipate bidding this project over the winter. **(No Council Action Required).**

Drumlin Drive Stream Cleaning

NJDEP permits have been issued for this project. Our consultant is finishing the design and we intend to bid the project over the winter. **(No Council Action Required).**

Jefferson Road Improvements

We received a \$760,000 NJDOT grant for improvements to Jefferson Road from Parsippany Road to Smith Road. The improvements include the resurfacing of the roadway, minor intersection upgrades and significant drainage improvements, particularly near the East Halsey Road intersection. Plans are in design and the project will be bid once NJDEP permits have been issued. **(No Council Action Required).**

Mt. Tabor Street Improvements, Phase VII

The Mt. Tabor Street Improvements, Phase VII project is in design. We anticipate bidding this project once funding is available. **(No Council Action Required).**

Lake Intervale Area Street Improvements

The first phase of the Lake Intervale Area Street Improvement project is in design. We anticipate bidding this project once funding is available. **(No Council Action Required).**

Troy Brook Stream Cleaning Sylvan Way Sidewalk Improvements River & Stream Desnagging Plans and Permits Entin Road Traffic Study Sylvan Way Culvert Improvements (No Council Action Required).

SMCMUA – Chemical Feed Building Right of Way Approval

The Southeast Morris County Municipal Utilities Authority proposes to construct a new building in the right of way adjacent to their existing facilities located near #1 Shongum Road on West Hanover Avenue between Shongum Road and Black Birch Drive. (A Resolution will need to be adopted by the Council authorizing the construction of the new building in the right of way).

Stickley Museum at Craftsman Farms Right of Way Approval
