Greenbank Road Safety and Improvements Project

All work is complete. Project closeout documents and the reimbursement request are being made to the NJDOT. (No Council Action Required).

2021 Road Resurfacing / Curb and Sidewalk Program

The annual road resurfacing / curb and sidewalk project is on hold pending negotiations with the contractor. (No Council Action Required).

<u>Puddingstone Heights Road Improvement Project, Phase I</u>

Construction on the Puddingstone Heights Improvement project is substantially complete. The contractor is working on completing the punch list items. (No Council Action Required).

Rockaway River Floodwall / Levee Inspection

Our consultant is working on preparing design details and a cost estimate for the maintenance and repair work to the flood wall and levee. All vegetation within 5 feet of the wall and toe of slope has been cleared in accordance with our inspection requirements. (No Council Action Required).

<u>Traffic Signal Maintenance for Littleton Rd. & Rita Dr./Beachwood Rd. and the Jefferson Rd. & Smith Rd. Intersections</u>

This project is for improvements and maintenance to the traffic signals located at the Littleton Road & Rita Drive/Beachwood Road intersection and the Jefferson Road & Smith Road

intersection. Construction is substantially complete and all punch list items will be finished in early December. (No Council Action Required).

2022 Road Resurfacing / Curb and Sidewalk Program

The 2022 road resurfacing / curb and sidewalk project is substantially complete. All work is anticipated to be complete by the end of November. (No Council Action Required).

North Beverwyck Road Streetscape Project, Phase I

The first phase of the North Beverwyck Road Streetscape project is in design. We anticipate bidding this project over the winter. (No Council Action Required).

Drumlin Drive Stream Cleaning

NJDEP permits have been issued for this project. Our consultant is finishing the design and we intend to bid the project over the winter. (No Council Action Required).

<u>Jefferson Road Improvements</u>

We received a \$760,000 NJDOT grant for improvements to Jefferson Road from Parsippany Road to Smith Road. The improvements include the resurfacing of the roadway, minor intersection upgrades and significant drainage improvements, particularly near the East Halsey Road intersection. Plans are in design and the project will be bid once NJDEP permits have been issued. (No Council Action Required).

Mt. Tabor Street Improvements, Phase VII

The Mt. Tabor Street Improvements, Phase VII project is in design. We anticipate bidding this project over the winter. (No Council Action Required).

<u>Lake Intervale Area Street Improvements</u>

The first phase of the Lake Intervale Area Street Improvement project is in design. We anticipate bidding this project once funding is available. (No Council Action Required).

Performance Bond Release - Palmar Associates, LLC., Block 450 Lot 14

The developer completed all site work in accordance with the approved plans associated with the Water's Edge Townhouse project. Inspections were made during the course of construction and this office has no objection to the release of Letter of Credit No. OD16002238. (A Resolution will need to be adopted by the Township Council).

Endorsement of the NJDOT Municipal Aid Grant

We are in the process of preparing and submitting a grant application through the NJDOT Local Transportation Projects Fund grant program. The application is for the rehabilitation of the Sylvan Way bridge culvert over the Malapardis Brook. Inspections of the culvert revealed advanced stages of deterioration of the concrete culvert. This application will help fund the repairs to the bridge culvert and road surface. (A Resolution endorsing the application will need to be adopted by the Township Council).
