G. ENGINEERING REPORT

2021 Road Resurfacing / Curb and Sidewalk Program

The annual road resurfacing / curb and sidewalk project is on hold pending negotiations with the contractor. (**No Council Action Required**).

Rockaway River Floodwall / Levee Inspection

Our consultant is working on preparing design details and a cost estimate for the maintenance and repair work to the flood wall and levee. Recent site inspections were made to aid the design of the repairs. Once the design and necessary permitting is complete the project will be advertised for bid. (**No Council Action Required**).

North Beverwyck Road Streetscape Project, Phase I

The first phase of the North Beverwyck Road Streetscape was awarded. Once contracts and other paperwork is executed a preconstruction meeting will be scheduled and a construction schedule provided. (No Council Action Required).

2023 Road Resurfacing / Curb and Sidewalk Program

The annual road resurfacing / curb and sidewalk project is substantially complete. Minor punch list items will be finished in the next several weeks and all work will be completed by the end of the month. (**No Council Action Required**).

Mt. Tabor Street Improvements, Phase VII

Construction on the Mt. Tabor Street Improvements, Phase VII project is substantially complete. Minor punch list items will be finished in the next several weeks and all work will be completed by the end of the month. (**No Council Action Required**).

Drumlin Drive Stream Cleaning

NJDEP permits have been issued for this project. Our consultant is finishing the design and we intend to bid the project later this year. (**No Council Action Required**).

Puddingstone Heights Road Improvement Project, Phase II

The second phase of Puddingstone Heights Road Improvement project is in design. We anticipated bidding the project later this year. (**No Council Action Required**).

Jefferson Road Improvements

The NJDEP permits and construction plans for the Jefferson Road project are in design. Permit applications and plan will be sent to the NJDEP later this year. The project will be bid once NJDEP permits have been issued. (**No Council Action Required**).

Lake Intervale Area Street Improvements

The first phase of the Lake Intervale Area Street Improvement project is in design. We anticipate bidding this project later this year or early in 2024. (**No Council Action Required**).

Sylvan Way Culvert Improvements

We are working with our design professionals on the preparation of plans and the NJDEP permit application. We anticipate bidding this project in early 2024. (**No Council Action Required**).

Edwards Road Improvements, Phase II

The second phase of the Edwards Road Improvement project, between Route 46 and New Road, is in design. We anticipate bidding this project early in 2024. (**No Council Action Required**).

North Beverwyck Road Streetscape Project, Phase II

The second phase of the North Beverwyck Road Streetscape is in design. We anticipate bidding this project in May 2024. (**No Council Action Required**).

No Parking Zone – Littleton Road

This office has received a request to investigate implementing no parking zones on Littleton Road to prohibit vehicles from parking along the edge of Littleton Road from the Route 287 overpass to Parsippany Boulevard. The Police Department and this office investigated this request and determined that parking should be prohibited on both sides of the street at all times. Amendment to Chapter 405, Section 14 is required. (An ordinance has been prepared and would need to be adopted by the Council).

Stop Signs – Mountain Way and Meadow Bluff Road

Stop signs were requested at the intersection of Mountain Way and Meadow Bluff Road due to safety concerns. An investigation was conducted by the office and the Police Department and it is recommended that Stop signs be installed at the corners of Mountain Way and Meadow Bluff road. Amendments to Chapter 405, Section 23 are required. (An ordinance has been prepared and would need to be adopted by the Council).

No Passing Zone - Mountain Way, Meadow Bluff Road

This office has received a request to investigate placing no passing zones on Mountain Way and on Meadow Bluff Road. Mountain Way and Meadow Bluff Road have posted speeds of 25 miles per hour and are both are very wide roadways. Vehicles travelling at the posted speed limit are frequently passed by faster vehicles creating unsafe conditions in the residential neighborhoods. The Police Department along with this office investigated the request and it determined that no passing zones are warranted. Amendments to Chapter 405, Section 34 are required. (An ordinance has been prepared and would need to be adopted by the Council).
