### **2021 Road Resurfacing / Curb and Sidewalk Program**

The annual road resurfacing / curb and sidewalk project is on hold pending negotiations with the contractor. **(No Council Action Required).**

### **Rockaway River Floodwall / Levee Inspection**

Our consultant is working on preparing design details and a cost estimate for the maintenance and repair work to the flood wall and levee. Recent site inspections were made to aid the design of the repairs. Once the design and necessary permitting is complete the project will be advertised for bid. **(No Council Action Required).**

### **North Beverwyck Road Streetscape Project, Phase I**

The first phase of the North Beverwyck Road Streetscape was awarded. Once contracts and other paperwork is executed a preconstruction meeting will be scheduled and a construction schedule provided. **(No Council Action Required).**

### **2023 Road Resurfacing / Curb and Sidewalk Program**

### **Mt. Tabor Street Improvements, Phase VII**
